As an Entrant licence holder you are entitled to the following benefits\*:

1. Access to Motorsport UK's Public Liability Insurance of up to £100 million covering you for all personal liability to third parties arising out of your Entrant activities, including the actions of drivers and team members present on the day, while competing in an event permitted by Motorsport UK or FIA on UK territory
2. Access to the Motorsport UK Personal Accident Insurance policy which provides cover during all official practice and competitive sessions including any foreign event organised under the authority of an FIA-recognised ASN
3. The Right to bring Protests and Appeals, be present and represent your driver and navigator in judicial matters
4. Judicial representation by Motorsport UK at the FIA Courts
5. Motorsport UK Judicial Hotline giving you access to legal and judicial advice for your Entrant related queries
6. Qualifies you to score points in events where there may be separate awards for Teams or Entrants

- I will not do anything that could damage the reputation of or have any negative effect on motorsport generally. I understand that if I do so, Motorsport UK may take disciplinary and/or other action against me (see General Regulations A.2.2.1.3, 2.2.1.4, H.3.1.2 and H.6).
- I undertake as the Entrant to ensure any person engaged by me to carry out work that is considered regulated activity as defined in Safeguarding Vulnerable Groups Act 2006 (SVGA) is in receipt of a suitability check at an enhanced level with barred list check issued by the DBS, PVG, or Access NI.
- I undertake to ensure any persons engaged by me are not subject to any Motorsport UK suspension or are on any Barred List.
- I undertake for the purpose of this application to never make use of nor knowingly allow any competitor entered by me to use or compete under the influence of drugs or of prohibited methods such as are defined in the Prohibited List of the World Anti-Doping Code of the WADA and by the Anti-Doping regulations of the FIA (see H38 or [www.wada-ama.org](http://www.wada-ama.org)) and understand if I do so, that Motorsport UK will take disciplinary action against me and my licence is likely to be permanently withdrawn.
- Motorsport UK operates a zero tolerance policy to the use of drugs and alcohol and I therefore confirm that I will not take part in nor allow any competitor entered by me to take part in any practice or competition while under the influence of drugs or alcohol and understand if I do so, that Motorsport UK will take disciplinary action against me and my licence is likely to be permanently withdrawn.
