Important Information for General Practitioners

Bolsover and North East Derbyshire District Councils require all drivers of Hackney Carriage and Private Hire vehicles to meet the DVLA Group 2 (bus and lorry drivers) medical standard.

Once you have completed the D4 medical examination report for a Group 2 (bus & lorry drivers) driving licence you should also complete the declaration below:

Using your personal information

Your personal data will be used for determining and monitoring your licence application. The lawful basis for this processing is 'public task' under the General Data Protection Regulation (GDPR, Art 6.1) and underpinned by the provisions of the Local Government (Miscellaneous Provisions) Act 1976 and Town Police Clauses Act 1847. The processing of criminal data (DPA s 10(5)) is being undertaken under DPA Schedule 1, paragraph 36 – substantial public interest. Failure to provide the personal information we need will mean that we cannot process your application or may call into question your fitness to continue to hold a licence with the Council.

We may share the information with other departments within the Council, other licensing authorities, government departments and/or other enforcing agencies. We may also get information about you from other organisations, or give information about you to them to: make sure the information is accurate; ascertain your fitness to hold a licence; prevent or detect crime and protect public safety. These organisations include government departments, other local authorities and private sector organisations including employers and Private Hire Operators.
